



## 2024-2025 Identity and Statement of Educational Purpose Worksheet Federal Student Aid Programs

Your 2024-2025 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm information you and/or your parents reported on your FAFSA. Your FAFSA, the information on this worksheet and any other required documents will be compared. If there are differences, corrections may be required. You may be asked for additional information. Try to complete verification as soon as possible, so that your financial aid won't be delayed.

### What you should do:

1. **To verify that you provided correct information, you and either an LCU Financial Assistance Employee or a Notary must complete and sign this worksheet.**
2. Talk to your financial aid administrator if you have questions about completing this worksheet.
3. **Complete the sections below and take the completed worksheet, and any required documents to LCU Financial Assistance.**

### B. Statement of Educational Purpose
